What You Need to Know

Thompson Health is pleased to offer **My Health eRecord**, a secure online tool for you to access portions of your personal medical record. Note that this tool is available for patients who were admitted as an inpatient or observation patient to F.F.Thompson Hospital after April 1, 2014.

Once you have completed the activation form and you have been discharged from the hospital, an email from RelayHealth will be sent to you within three business days. In this email, there will be instructions on how to activate your clinical information.

Frequently Asked Questions

When can I see the information in My Health eRecord? The online gateway is activated immediately after you are discharged from the hospital. The information will be updated again within a few days after discharge.

Is my medical information secure? The **My Health eRecord** online gateway employs the highest level of security and encompasses the security tenets of the proposed regulations of the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Our overall priorities are to ensure security and to be fully compliant with all HIPAA regulations. Access, integrity, availability, ownership, authorization, dependability, authentication and confidentiality are all major considerations within the system.

What is the privacy policy for the My Health eRecord system? The Thompson Health online gateway is fully compliant with federal and state laws pertaining to your privacy. Your name and email address will be treated with the same care and privacy given to your health records and will never be sold or leased by Thompson Health.

Step 1

During Registration, provide the hospital Registrar with a valid email address.

Step 2

Upon discharge, you will receive an email with a link to the Patient Portal.

Step 3

Check your email and use the link to launch the online Patient Portal.

Step 4

You will be prompted to enter your date of birth to confirm your identity.
